Basic Concepts - Defense as Public Good

THEORETICAL DEMARCATION

- Firstly consumption of the good by one person does not reduce the amount available for others to consume.
- Secondly the benefits that a given person derives from the provision of a collective good do not depend on that individual's contribution to funding it. Everyone benefits, including those who pay little or no taxes. ("free ride" problem).





Basic Concepts - Defense Adequacy

FIRST NOTICE

OLVEY, F. The National Security. New York, 1974

DEFINITION

- Defense adequacy is possible to define as current real degree of peace defence doctrine securing possibilities. Defense adequacy is derived from aims and tasks of defence of state during crisis.
- Determination of defence adequacy means creation and presentation of proposal:
 - Organization structure
 - Number of persons
 - Number and structure weapons,
- In variations, which enable to fulfil the tasks of defence doctrine.





Basic Concepts - Defense Adequacy

- Nominated variations have to be supplemented by expression its expensiveness.
- Inseparable part of these designs have to be plan of modernisation or armed forces refit.

NOWADAYS PROBLEMS

- Changed security environment
- Question: Possibilities to plan necessary defence capacity versus defence ability.

COMPARISON

Eisenhower told his senior defence team that he wanted the Pentagon cut down to a "Spartan basis."



Resource Allocation Efficiency TO DEFENSE

- What level defence expenditure is still rational in comparison to another social expenditures (trade-offs).
 - ".... ...our military cannot be built to do "everything."" (Building a Military for 21st century)
- Defense expenditure is needed to understand as a certain form of insurance, which society has to pay for its external security (analogy with mandatory insurance and car/automobile insurance).
- INTERRELATIONSHIP BETWEEN BENEFIT OF DEFENSE GOOD AND BENEFIT FROM DEFENSE EFPENTIDURE !!!

Resource Allocation Efficiency TO DEFENSE

RELATIONSHIP BETWEEN BENEFIT FROM DEFENSE AND BENEFIT FROM DEFENSE EXPENDITURE

- If, however, the collective goods that government provides can be transformed into private ones—that is, if provision of collective goods yields ancillary benefits that some majority coalition of voters views as particularly beneficial to them—then the problem of governmental under provision of collective goods can be at least partially offset.
- National defence spending does yield such ancillary benefits to special interests;
 - defence contractors,
 - defence-related workers, and
 - communities with military bases are examples





Efficiency Understanding Levels Under Conditions Of Defence

Resource Allocation Efficiency TO DEFENSE RELATIONSHIP BETWEEN BENEFIT FROM DEFENSE AND BENEFIT FROM DEFENSE EXPENDITURE

Such interest groups benefiting from defense spending are located in a
majority of congressional districts and in a majority of states. Their presence,
therefore, offsets the bias toward too little defense spending under
democratic institutions. Ironically, the geographic (and political) dispersion of
military bases, defense contracts, and other seemingly "wasteful" dimensions
of defense spending—not to mention transfer programs seemingly unrelated
to defense—could make government budgeting more efficient rather than
less.



Capital expenditure

What extent does Capital expenditure help to react and destroy existing or newly appearing threats?
 What to some extent does acquisition system able to secure the needs of armed in optimal relation between price and required qualitative and quantitative attributes.

Problem of time (life cycle of new weapon system development)
 Problem of lobbying interest groups (corruption, requirement of new up-to-date non-existing attributes).
 Problem of "Tribalism in Defense" (PAUL CORNISH AND ANDREW DORMAN National

defence in the age of austerity)

Common expenditures
 To some extend does common expenditure secure adequate condition for functioning of armed forces and adequate training of all sorts of troops?





Efficiency Understanding Levels Under Conditions Of Defence

Resource Allocation Efficiency IN DEFENSE

- Efficiency could be result in real structuration and evaluation cost, effects and losses.
- Objectivity, responsibility and transparency as partial aspects of efficiency could be result in:
 - Refusal subjective dogmatic approaches and opinions including rejection of "critical" investment projects.
 - Creation of normative basement and correct relationships within <u>process of economic management</u>.

Defense Department Failure In Connection Of Efficiency

Government failure and department of defence

- Limited information, which government has to use and operating.
- Limited control on private sector reaction in connection on government activity.
- Limited control on its own bureaucracy.
- Restriction resulted from origin of policy decision making process.

Support Tools Of Department Of Defense Efficiency

- External conditions of efficiency of public sector are:
 - Political organization of society,
 - Functioning market sector..
- Internal conditions of efficiency of public sector are:
 - Comprehensible and sufficiently clearly formulation of organization mission and aims,
 - Competiveness of environment inside of public sector,
 - Financing of public sector by benefits and performance,
 - Public Control.





Support Tools Of Department Of Defense Efficiency

Efficiency Factors

- -Science and technology factor,
- -Knowledge of all activities structure,
- -Usage of all division of labour forms,
- Qualification of workers,
- Initiative of workers,
- Management system.

Defence Resource Allocation Efficiency Conclusion

- The DoD's own incentives for efficient operations are weak relative to those in the private sector.
- Department of Defense, "cannot reset the current force, modernize and transform in all portfolios at the same time. Choices must be made across capabilities and within systems to deliver capability at known prices within a specific period of time."
- In order to make these important decisions, the government will first have to evaluate the current state of the military; examine the current composition of the Defense budget; and define the threats, challenges, and role of the military in the 21st century.
